- b) Eastern Ontario Health Unit Guest Speaker:
  - Robert Sarrazin provided the Raisin-South Nation Source Protection Committee with an update on the role of the Eastern Ontario Health Unit (EOHU) with regards to Ontario Reg. 318/319.
  - o It was noted that Ontario Reg. 318 is a transitional regulation and will cease as of the 1<sup>st</sup> of June 2010 at which time Ontario Reg. 319 takes effect.
  - o It was also noted that there is an estimated six hundred to one thousand small drinking water systems in the EOHU's jurisdiction.
- c) Development of Assessment Reports:
  - O Angela Coleman reviewed the staff report with the Raisin-South Nation Source Protection Committee to provide an update on the status of the municipal surface and groundwater studies and to discuss how information collected from the studies will be presented and integrated into Assessment Reports.
  - Rob Muir of Dillon Consulting provided a sample presentation and a request was extended to all SPC members to provide input into the proposed presentation structure.
  - o It was suggested that attendees be requested to curtail questions during the presentation and that slides be clearly numbered to allow for questions to be posed on specific information upon completion of delivery of all information.
  - o It was also suggested that sessions be limited to one and a half to two hours with concise handouts and maps/displays around the room.
  - O It was further suggested that timing should be the latter part of the evening to accommodate the agricultural community and that participants be afforded the opportunity to ask questions privately at the end of the session.
  - o It was also further suggested that dates be announced as soon as possible to allow for attendance by SPC members (sanctioned by the SPC Chair if remuneration is to be requested) and it was announced that members advise staff of any specific session that would be of particular interest to them.
  - O A discussion ensued with respect to the negative impact of wildlife versus livestock and it was agreed that while this issue may not be within the parameters of the *Clean Water Act*, this does not preclude the Raisin-South Nation Source Protection Committee from lobbying for some resolution on this issue. Staff will look into this issue and update the SPC at the next meeting.
